Services to be provided by THE BBQ SHACK

Services rendered by THE BBQ SHACK shall be as described by the method noted below:

- 1) Whole Hog - Roasted whole hog (skin on), delivered to event site, customer responsible for carving, shredding, containers, and serving.
- 2) Whole Hog - Roasted whole hog (skin on), delivered to event site. Carving, shredding, containers provided by THE BBQ SHACK available for an additional charge.
- 3) Whole Hog, quartered - Whole hog delivered in quarters wrapped in foil. Customer responsible for boning, shredding, and containers.
- 4) Whole Hog, quartered - Whole hog quarters boned, defatted, shredded and delivered in aluminum pans ready for serving. Customer responsible for serving.
- 5) Event Plate Options - THE BBQ SHACK provides all meat, side dishes, buns/bread, heavy-duty styrofoam plates, eating utensils, napkins, and BBQ sauce. Customer is responsible for all tables, chairs, canopies, decorations, etc.

Note: The BBQ SHACK guarantees one full-plate-serving for the total serving amount indicated above base on 1/3 lb per person (per plate). Servers may be required to insure servings of equal amounts.

Limited Liability

THE BBQ SHACK maintains general liability insurance to cover any negligent acts committed by employees or agents of THE BBQ SHACK during the performance of services rendered. THE BBQ SHACK will not be liable to customer, or to anyone who may claim any right due to a relationship with customer, for any acts or omissions in the performance of services under the terms of this agreement or on the part of employees or agents of THE BBQ SHACK unless such acts or omissions are due to willful misconduct. Customer will indemnify and hold THE BBQ SHACK free and harmless from any obligations, costs, claims, judgments, attorneys' fees, and attachments arising from, growing out of, or in any way connected with the services rendered to customer by THE BBQ SHACK under the terms of this agreement, unless THE BBQ SHACK is judged by a court of competent jurisdiction to be guilty of willful misconduct. Additionally, in the case of multiple caterers/vendors during any event, the customer agrees to hold THE BBQ SHACK free and harmless from any and all claims arising from any such negligent acts by other catering firms.

Terms of Changes , Cancellation, or Reschedule

All catering changes for the event, cancellations, or rescheduling must be made 7 days prior to the event. 100% of deposits shall be refunded for all cancellations made 7 days prior to the event. Deposits shall be retained by THE BBQ SHACK for all cancellations made the day of event less 6 days, with exception of cancellations due to death or serious illness/injury. For rescheduled events, THE BBQ SHACK shall retain the deposit. THE BBQ SHACK reserves the right to cancellation of catering any event, any time prior to the event. Under such circumstances, 100% of deposit shall be refunded by THE BBQ SHACK.

Terms of Payment

THE BBQ SHACK requires a 50% deposit (via credit card, cashiers check, money order, or cash) of estimated cost to secure the event date. At the minimum, 50% is due 2 weeks prior to the event date. The balance is due no later than 48 hours prior to the date of the event (unless approved otherwise) or THE BBQ SHACK does not cater the event. Additional charges incurred the day of event will be due upon completion of event catering. Company checks will be accepted upon approval of The BBQ SHACK.
